Medical Information Requirements for Admission to Calvary Baptist School

To help ensure the safety of all children attending Calvary Baptist School, and in keeping with Pennsylvania state law, the following information is required of all domestic students in order to begin attending Calvary Baptist School:

- 1. Full immunization records must be submitted (see attached list of requirements)
 - a. All single dose vaccines must be given prior to attending school
 - b. Multiple dose vaccines not completed must have the first dose given and a schedule to accomplish the additional doses:
 - i. Schedule will be reviewed every 30 days
 - ii. All doses of multiple dose vaccinations must be accomplished within 5 days for new students or a medical certificate signed by a doctor with the date the next vaccination is to be given if not medically feasible to accomplish within the first 5 days, or per Pennsylvania State law, the student can be excluded from attending Calvary Baptist School.
 - c. Exemptions may be granted for two reasons:
 - i. Medical exemption a written statement must be submitted from a physician stating that a particular immunization would be detrimental to a student's health. When the physician determines a student can take the immunization, the student will need to do so according to the state requirements.
 - ii. Religious exemption children need not be immunized if the parent, guardian, or emancipated child objects in writing to the immunization on religious grounds or on the basis of a strong moral or ethical conviction similar to a religious belief.
- 2. The school emergency form filled out and signed
- 3. A physical exam must be filled out by your physician and turned in to the school upon entrance. Physical exams are also required at the following times:
 - a. Prior to entering kindergarten/1st grade
 - b. Prior to entering 6th grade
 - c. Prior to entering 11th grade
- 4. A dental exam must be filled out by your dentist and turned in to the school by upon entrance. Dental exams are also required at the following times:
 - a. Prior to entering kindergarten (or/1st grade if the child did not attend kindergarten)
 - b. Prior to entering 3rd grade
 - c. Prior to entering 7th grade
- 5. Any student who uses/carries an inhaler or epi pen or takes medication while at school must supply a current prescription of either/both and a current doctor's orders with instructions for use

Immunizations Required for Attendance to Calvary Baptist School

As per Pennsylvania state law, any student attending Calvary Baptist School must have the following immunizations completed or scheduled in order to begin attending classes:

All Students

- 4 doses of Tetanus (1 dose on or after their 4th birthday)
- 4 doses of Diphtheria (1 dose on or after their 4th birthday)
 - Above usually given together and shows as DTaP or DTP on a student's records
- 2 doses of Measles
- 2 doses of Mumps
- 1 dose of Rubella (German Measles)
 - Above usually given together and shows as MMR on a student's records
- 4 doses of Polio (one dose on or after their 4th birthday)
- 3 doses of Hepatitis B
- 2 doses of Varicella (Chickenpox) or evidence of immunity

Entering 7th Grade

- 1 dose Meningococcal Conjugate Vaccine (MCV)
- 1 dose Tetanus/Diphtheria/Acellular Pertussis (Tdap)

(If 5 years or more has elapsed since last tetanus immunization)

Entering 12th Grade

1 dose of Meningococcal Conjugate Vaccine (MCV)

(if first dose was given after the age of 16, the 2nd dose in 12th grade is not needed.
